#### Housing and heating costs


You, or the person you care for, may be able to get extra money to help pay for housing costs.

- Help with interest on your mortgage payments if you own your home and claim benefits.
- Council Tax Reduction (also known as Council Tax Support) which can give a discount on your Council Tax bill if you have a low income or claim benefits. Find out more on gov.uk.
- Extra help from energy suppliers' Priority Services Register or Customer Care Register.
- Help heating your home including the Cold weather payment, the Warm Home Discount Scheme, and the Winter fuel payment.
